

## Privacy policy pursuant to Article 13 of Regulation (EU) 679/2016

<b>Data Controller</b>	Marina di Loano S.p.A. ( <a href="http://www.marinadiloano.it">www.marinadiloano.it</a> ), with registered office at Lungomare Nazario Sauro n. 12/1 – 17025 Loano (SV), Italy.
<b>Purpose and legal basis of processing</b>	Pursuant to Article 13 of Regulation (EU) 679/2016 (hereinafter referred to as 'the Regulation'), we hereby inform you that the service of connectivity to the Internet via Wi-Fi (also referred to as the 'Service'), entails the processing of personal data relating to you. The basis of the processing consists of the need to perform a service you have requested; its purpose is to allow you to access the network.
<b>Categories of data and nature of provision</b>	Your personal data (first name and last name) are needed for the purpose of activating the Service; the use of the Service (for which a user account will be created and linked to credentials that cannot be directly traced back to you), entails the processing of data relating to your access to the network and/or your browsing device. The provision of your data is a necessary requirement for the activation of the Service.
<b>Processing methods</b>	Your data will not be disseminated and will be processed in electronic form, using instruments that ensure their security and confidentiality; they may become known, within the structures of our Company, by persons we trust and who are appointed by us as Data Processors, who carry out, on our behalf, technical, IT and organisational operations that are strictly necessary for the performance of the aforementioned activities or for network maintenance services; for the latter purpose, the data may, if strictly necessary, be disclosed to persons entrusted with the performance of such maintenance activities and with whom a special agreement on the processing of data has been (or will be) entered into, through which they have been (or will be) designated as Data Processors.
<b>Retention periods</b>	Your personal data will be retained until you stop using the Service.
<b>Rights of the data subject</b>	The privacy regulation (Articles 15-22 of the Regulation) guarantees you the right to access your data at any time, as well as to have them corrected and/or supplemented, if inaccurate or incomplete, to have them deleted or their processing limited, if the relevant conditions are met, to object to their processing for reasons related to your particular situation, and to request the portability of the data you have provided, if they are processed automatically for the contractual services you have requested, within the limits of the Regulation (Article 20).
<b>Data Protection Officer</b>	The 'Data Protection Officer' is at your disposal to answer any questions you may have or to provide clarifications: to this end, you may contact him/her at the aforementioned registered office of Marina di Loano S.p.a. or by sending an e-mail to <a href="mailto:privacy@marinadiloano.it">privacy@marinadiloano.it</a> . You can contact the data protection officer not only to exercise your rights, but also to obtain an updated list of the categories of data recipients.
<b>Right to submit a complaint to the Privacy Guarantor</b>	In addition, your right to lodge a complaint with the Italian authority, the Privacy Guarantor, where deemed necessary for the protection of your personal data and your related rights, remains unaffected.
